THE RECTOR OF UNIVERSITAS DIPONEGORO

Considering:

- a. that Universitas Diponegoro in the context of admission of new students needs to determine the selection path for admission of new prospective students of Universitas Diponegoro;
- b. that based on Article 20 of the Government Regulation Number 52 of 2015 on the Statute of Universitas Diponegoro, Undip implements a student admission system for all levels of education and establishes further provisions regarding the selection and admission of new students:
- c. that to implement the Regulation of the Minister of Education and Culture Number 6 of 2020 on New Student Admissions for Bachelor's Degree Program at State Higher Education Institutions;
- d. that based on these considerations, it is necessary to enact a Regulation of the Rector of Universitas Diponegoro on the Selection of New Student Admissions in Universitas Diponegoro Environment;

To enact:

REGULATION OF THE RECTOR OF UNIVERSITAS DIPONEGORO ON SELECTION PATH OF NEW STUDENT ADMISSIONS AT UNIVERSITAS DIPONEGORO.

CHAPTER I GENERAL PROVISIONS

Article 1

In this Rector Regulation:

- 1. Minister is the Minister who administers government affairs in the field of higher education.
- 2. Universitas Diponegoro hereinafter referred to as Undip, is a legal entity state university.
- 3. Statutes of Undip are the basic regulation of Undip management which are used as the cornerstone for the formulation of regulations and operating procedures at Undip.
- 4. Board of Trustees, hereinafter abbreviated as MWA, is an Undip organ that determines, provides considerations for the implementation of general policies, and carries out supervision in non-academic fields.
- 5. Academic Senate, hereinafter abbreviated as SA, is an Undip organ that determines policies, provides considerations, and carries out supervision in the academic field.
- 6. Rector is Undip organ that leads the organization and management of Undip.
- 7. Dean is the Head of Faculty or School at Undip who is in charge and responsible for the implementation of education in each Faculty or School.
- 8. Lecturers are professional educators and scientists with the main task of transforming, developing and disseminating science and technology through education, research, and community service.
- 9. Academic Staff are members of the community devoting themselves and are appointed with the main task to support the implementation of higher education at Undip.
- 10. Undip Alumni Association or known as IKA Undip is graduates with high tiering at Undip.

11. Vocational...

- 11. Vocational Program is a higher education that supports the mastery of certain applied skills, including Diploma 3 and Diploma 4 degrees (Applied Bachelor) education programs.
- 12. Bachelor's Degree Program is an academic education intended for graduates of secondary education or equivalent so that they are able to practice science and technology through scientific reasoning.
- 13. National Selection to Enter State Universities, hereinafter abbreviated as SNMPTN, is a selection program that is carried out based on the tracking results of academic, non-academic achievements, and/or portfolios of prospective students.
- 14. Joint Entrance Selection of State Universities, hereinafter abbreviated as SBMPTN, is a selection program that is carried out based on the results of the Computer-Based Writing Examination (UTBK) and can be added with other criteria in accordance with the special talents determined by the State University concerned.
- 15. Independent Selection, hereinafter abbreviated as UM, is a selection that is carried out independently by Undip based on its autonomy.
- 16. Independent Selection is an independent-selection scheme for new student admissions in the form of a general written test.
- 17. Independent Selection of Institutional Cooperation Pattern, hereinafter abbreviated as UM PKSI, is an independent selection scheme for new student admissions in a written form intended for institutions or third parties that have institutional cooperation with Undip.
- 18. International Undergraduate Program (IUP) path is designed as a special class for international and domestic students using English as a medium of communication in all campus activities.
- 19. Potential Student Selection Program (PSSB) is the admission path for Applied Bachelors at the Vocational School of Universitas Diponegoro through the achievement of academic scores.
- 20. Independent Selection (UM) for Diploma IV/ Applied Bachelors is carried out by performing selection through a written test which is held on campus and/or outside Undip.
- 21. International students are foreigners who study at Undip.
- 22. High Achieving Student Selection hereinafter abbreviated as SBUB, is a selection pattern for new student admissions at Undip in the form of practice specifically intended for prospective students who have superior achievements in their fields;
- 23. Selection for the Education of Master to Doctorate for Outstanding Bachelors (PMDSU) is a selection pattern of accelerated education scholarship given to graduates of Bachelor's Degree who meet the qualifications to become a Doctor with a 4 (four) year education period assisted by the Promoter.

- 24. Faculty is a set of supporting resources, which conducts and manages academic and professional education in one discipline cluster of scientific and technology.
- 25. School is a faculty-level academic implementing element in charge of organizing and/or coordinating multidisciplinary postgraduate, professional or vocational programs.
- 26. Department is an element of Faculty or School that supports the implementation of academic activities in one or several branches of science and technology in academic, professional, or vocational education.
- 27. Study Program is a unit of educational and learning activities that has certain curriculum and learning methods in one type of academic, professional, and/or vocational education.
- 28. Division is an element of the Medical Faculty that supports the implementation of academic activities in a branch of science and technology in the type of professional education;
- 29. Undip employees consist of lecturers and academic staff of Civil Servant/Non-Civil Servant/Contract Civil Staff Apparatus of Undip.

CHAPTER II PRINCIPLES AND SCOPE

Article 2

New Student Admission System at Universitas Diponegoro is organized with the following principles:

- a. objective, meaning that the selection results are based on the potentials and academic achievements of the prospective students and the specificity of the Study Program concerned;
- b. accountable, meaning that it is implemented in accordance with clear procedures and criteria;
- c. transparent, meaning that the implementation of admission is carried out transparently and the results of the implementation can be accessed easily;
- d. non-discriminatory, meaning that it is not differentiating religion, ethnicity, race, gender, age, social status, physical condition, and economic status of prospective students; and
- e. paying attention to equal distribution of education, that is providing opportunities for all Indonesian citizens as wide as possible to be able to receive education.

Article 3

Scope of Selection of New Student Admissions of Universitas Diponegoro includes:

- a. Selection of New Student Admissions for Vocational Program;
- b. Selection of New Students Admission for Bachelor's Degree Program;
- c. Selection of New Student Admissions for Postgraduate Program;
- d. Selection of New Student Admissions for Specialist Doctor Education Program (PPDS);
- e. Selection of New Student Admissions for Professional Education Program.

CHAPTER III

SELECTION PATHS FOR NEW STUDENT ADMISSIONS

Article 4

Selection Paths for New Student Admission of Universitas Diponegoro consist of:

- a. Bachelor's Degree Program:
 - 1) National Selection to Enter State Universities (SNMPTN);
 - 2) Joint Entrance Selection of State Universities (SBMPTN);
 - 3) High Achieving Student Selection (SBUB); and
 - 4) Independent Selection (UM) for Bachelor's Degree.
- b. Vocational Program:
 - 1) Potential Student Selection Program (PSSB) for D-IV / Applied Bachelor;
 - 2) High Achieving Student Selection (SBUB) for DIV/ Applied Bachelor; and
 - 3) Independent Selection (UM).
- c. Independent Selection (UM) for Postgraduate Program.
- d. Independent Selection (UM) for Specialist Doctor Education Program (PPDS).
- e. Independent Selection (UM) for Professional Program.

CHAPTER IV

SELECTION OF NEW STUDENT ADMISSION FOR BACHELOR'S DEGREE PATH

Section One

National Selection to Enter State Universities (SNMPTN)

Article 5

- (1) SNMPTN path is implemented nationally by Higher Education Entrance Test Institute (LTMPT) based on the provisions regulated by the Minister.
- (2) SNMPTN Implementation Team at Undip is appointed and dismissed by Rector Decree:
- (3) SNMPTN Implementation Team at Undip as referred to in paragraph (2) is chaired by the Vice Rector for Academic and Student Affairs and is responsible to the Rector.

Section Two...

Section Two Joint Entrance Selection of State Universities (SBMPTN)

Article 6

- (1) SBMPTN path is implemented nationally by Higher Education Entrance Test Institute (LTMPT) based on the provisions regulated by the Minister.
- (2) SBMPTN Implementation Team at Undip is appointed and dismissed by Rector Decree;
- (3) SNMPTN Implementation Team at Undip as referred to in paragraph (2) is chaired by the Vice Rector for Academic and Student Affairs and is responsible to the Rector.

Section Three High Achieving Student Selection (SBUB)

Article 7

- (1) High Achieving Student Selection (SBUB) is carried out to accommodate prospective new students who have high achievements in the fields of:
 - a. Art;
 - b. Culture;
 - c. Sports;
 - d. Science and knowledge; and
 - e. Other outstanding achievements.
- (2) High achievement is the minimum achievement at the national level and/or achievements that are assessed by the SBUB Implementation Team as extraordinary advantages possessed by prospective new students when they were at Senior High School or equivalent.
- (3) SBUB is implemented in the following stages:
 - a. Registration;
 - b. Achievement tracking and assessment;
 - c. Skill test and interview; and
 - d. Announcement.
- (4) SBUB is carried out by SBUB Implementation Team appointed and dismissed by Rector Decree.
- (5) SBUB Implementation Team as referred to in paragraph (4) is chaired by the Vice Rector for Academic and Student Affairs and is responsible to the Rector.
- (6) Further provisions regarding SBUB are enacted in Rector Decree.

Section Four...

Section Four Independent Selection (UM) for Bachelor's Degree

Article 8

- (1) Independent Selection (UM) for Bachelor's Degree consists of:
 - 1. Regular Path includes:
 - a. Indonesia Smart Card (KIP) Path;
 - b. Partnership Path; and
 - c. Cooperation Path.
 - 2. International Undergraduate Program (IUP) Path;
 - 3. International Student Path; and
 - 4. Other paths set by the Rector.
- (2) Independent Selection (UM) for Bachelor's Degree is carried out by the Implementation Team appointed and dismissed by Rector Decree.
- (3) Implementation Team of Independent Selection (UM) for Bachelor's Degree as referred to in paragraph (2) is chaired by the Vice Rector for Academic and Student Affairs and is responsible to the Rector.

Paragraph 1 Regular Path

Article 9

- (1) Independent Selection (UM) for Bachelor's Degree from Regular Path is carried out in writing or in other forms by Undip;
- (2) Participants of Independent Selection (UM) for Bachelor's Degree from Regular path are SMA/SMK/MA graduates or equivalent in the last 3 years.
- (3) In organizing the Independent Selection (UM) from Regular Path, Undipmay cooperate with IKA Undip and/or other parties.
- (4) The cooperation as referred to in paragraph (3) is stated in the agreement.

Indonesia Smart Card (KIP) Path

Article 10

- (1) Indonesia Smart Card (KIP) Path is an Independent Selection Program (UM) for Bachelor's Degree from Regular path that is intended for participants who come from economically disadvantaged families/or KIP holders.
- (2) Requirements for Indonesia Smart Card (KIP) Path participants include:
 - a. KIP holders;
 - b. Students from poor / vulnerable to poverty households with specific considerations;

c.SMA/SMK/MA...

- c. SMA/SMK/MA graduates or equivalent in the last 3 (three) years;
- d. Participants are KIP holders at least 12 (twelve) months prior to the selection.
- (3) Further provisions regarding the implementation of new student admissions through Independent Selection (UM) from Indonesia Smart Card (KIP) path are enacted by Rector Decree.

Partnership Path Article 11

- (1) Partnership path of Independent Selection is carried out by holding special written exams and/or other forms with third parties who carry out Cooperation of New Student Admissions (KPMB) with Undip.
- (2) Partnership path of Independent Selection can be performed by holding written exams or other forms of individual or group tests.
- (3) The Rector appoints and dismisses a third party as KPMB partner by Rector Decree.
- (4) Technical provisions regarding the KPMB pattern with third parties are regulated in the KPMB contract.
- (5) Partnership path of Independent Selection is carried out in the following stages:
 - a. Registration;
 - b. Written test; and
 - c. Announcement.
- (6) Further provisions regarding the Independent Selection (UM) through Partnership Written Examination are enacted in Rector Decree.

Cooperation Path Article 12

- (1) Cooperation path of Independent Selection is carried out by holding special written exams with third parties who perform Cooperation of New Student Admissions (KPMB) with Undip.
- (2) The Rector appoints and dismisses a third party as KPMB partner by Rector Decree.
- (3) Technical provisions regarding the KPMB pattern with third parties are regulated in the KPMB contract.
- (4) The Cooperation UM path is carried out in the following stages:
 - a. Registration;
 - b. Written test; and
 - c. Announcement.
- (5) Further provisions regarding the Independent Selection (UM) through Cooperation Path are enacted in Rector Decree.

Paragraph 2...

Paragraph 2 International Undergraduate Program (IUP) Path

Article 13

- (1) Independent Selection (UM) of Bachelor's Degree from IUP Path is designed to produce graduates who are globally competitive and provide opportunities as wide as possible for prospective national and international students.
- (2) Independent Selection (UM) of Bachelor's Degree from IUP Path is carried out in the following stages:
 - a. Registration;
 - b. Written Academic Potential (TPA) and English tests;
 - c. Interview; and
 - d. Announcement.
- (3) Further provisions regarding the Independent Selection (UM) of Bachelor's Degree from IUP Path are enacted in Rector Decree.

Paragraph 3 International Student Path; and

Article 15

- (1) Independent Selection (UM) of Bachelor's Degree from International Student Path is designed to accept prospective foreigners with a class model together with regular classes.
- (2) Independent Selection (UM) of Bachelor's Degree from International Student Path is carried out in the following stages:
 - a. Registration;
 - b. Portfolio selection;
 - c. Interview; and
 - d. Announcement.
- (3) Independent Selection (UM) of Bachelor's Degree from International Student Path can be carried out online.
- (4) The Rector can appoint an authorized official in carrying out international student admission activities.
- (5) Further provisions regarding the Independent Selection (UM) of Bachelor's Degree from International Student Path are enacted in Rector Decree.

CHAPTER V...

CHAPTER V SELECTION OF NEW STUDENT ADMISSION FROM VOCATIONAL PATH

Selection Pattern

Section One

Potential Student Selection Program (PSSB) for D-IV/Applied Bachelor

Article 16

- (1) Potential Student Selection Program (PSSB) for D-IV/Applied Bachelor is held by the Implementation Team appointed and dismissed by Rector Decree.
- (2) The Implementation Team as referred to in paragraph (1) is chaired by the Vice Rector for Academic and Student Affairs and is responsible to the Rector.
- (3) Further provisions regarding the implementation of the Potential Student Selection Program for D-IV/Applied Bachelor are enacted by Rector Decree.

Section Two

High Achieving Student Selection (SBUB) for D-IV/Applied Bachelor

Article 17

- (1) High Achieving Student Selection (SBUB) for D-IV/Applied Bachelor is carried out to accommodate prospective new students who have outstanding achievements in the fields of:
 - a. Art;
 - b. Culture;
 - c. Sports;
 - d. Science and knowledge; and
 - e. Other outstanding achievements.
- (2) Outstanding achievement is the minimum achievement at the provincial level by winning the 1st position, at the national/international level by winning in the 1st, 2nd, and 3rd position and/or achievements that are assessed by the SBUB Implementation Team as extraordinary advantages possessed by prospective new students when they were at SMA/SMK/MA.
- (3) High Achieving Student Selection (SBUB) for D-IV/Applied Bachelor is carried out in the following stages:
 - a. Registration;
 - b. Achievements tracking and assessment;
 - c. Skill test and interview test; and
 - d. Announcement.
- (4) High Achieving Student Selection (SBUB) for D-IV/Applied Bachelor is held by the Implementation Team who is appointed and dismissed by Rector Decree.

(5) The Implementation...

- (5) The Implementation Team as referred to in paragraph (4) is chaired by the Vice Rector for Academic and Student Affairs and is responsible to the Rector
- (6) Further provisions regarding High Achieving Student Selection (SBUB) for DIV/Applied Bachelor are enacted in Rector Decree.

Section Three Independent Selection (UM) for D-IV/Applied Bachelor

Article 18

- (1) Independent Selection (UM) for D-IV/Applied Bachelor consists of:
 - a. Regular Path;
 - b. Collaboration Path;
 - c. Study Program Outside Main Campus (PSDKU) Path; and
 - d. Advanced Path from D-III to D-IV/Applied Bachelor.
- (2) Further provisions regarding the Independent Selection for D-IV/Applied Bachelor are enacted in Rector Decree.

Paragraph 1 Regular Path

Article 19

- (1) Independent Selection (UM) for D-IV/Applied Bachelor from Regular Path is carried out in writing by Undip;
- (2) In the implementation of the Independent Selection (UM) for D-IV/Applied Bachelor, Undip can cooperate with third parties.
- (3) The cooperation as referred to in paragraph (2) is stated in the agreement.
- (4) Further provisions regarding the Independent Selection (UM) for D-IV/Applied Bachelor from Regular Path are enacted in Rector Decree

Paragraph 2 Cooperation Path

Article 20

- (1) Independent Selection for D-IV/Applied Bachelor from Cooperation Path is carried out by Undip by holding special written exams with third parties or agencies carrying out Cooperation of New Student Admission (KPMB) with Undip.
- (2) The Rector appoints and dismisses a third party as KPMB partner by Rector Decree.

(3) Technical provisions...

- (3) Technical provisions regarding the KPMB pattern with third parties are regulated in the KPMB contract.
- (4) Independent Selection (UM) for D-IV/Applied Bachelor from the Cooperation Path is carried out in the following stages:
 - a. Registration;
 - b. Written test; and
 - c. Announcement.
- (5) Further provisions regarding the Independent Selection (UM) for D-IV/Applied Bachelor from Cooperation Path are enacted in Rector Decree.

Paragraph 3 Study Program Outside Main Campus (PSDKU) Path

Article 21

- (1) Independent Selection (UM) for D-IV/Applied Bachelor from Study Program Outside Main Campus (PSDKU) is held in several regions, including:
 - a. Semarang;
 - b. Pekalongan;
 - c. Batang;
 - d. Demak;
 - e. Rembang.
- (2) Further provisions regarding the implementation of the Independent Selection (UM) for D-IV/Applied Bachelor from Study Program Outside Main Campus (PSDKU) are enacted by Rector Decree.

Paragraph 4 Advanced Path from D-III degree to D-IV/Applied Bachelor

Article 22

- (1) Independent Selection of Advanced Path from D-III to D-IV/Applied Bachelor is held at Universitas Diponegoro based on the provisions set by the Rector of Universitas Diponegoro.
- (2) Further provisions regarding the implementation of the Independent Selection of Advanced Path from D-III to D-IV/Applied Bachelor are enacted by Rector Decree.

CHAPTER VI...

CHAPTER VI SELECTION OF NEW STUDENT ADMISSION FOR POSTGRADUATE PATH

Selection Pattern

Article 23

Selection of New Students Admission for the Postgraduate program consists of:

- a. Independent Selection (UM) for Postgraduate Master's Degree Program;
- b. Independent Selection (UM) for Postgraduate of Institutional Cooperation Pattern (PKSI);
- c. Independent Selection (UM) for Postgraduate Doctoral Program;
- d. Selection for Prospective Students of Master's Degree to Doctoral Degree Program for Excellence Graduates (PMDSU).

Section One

Independent Selection (UM) for Postgraduate Master's Degree Program

Article 24

- (1) Independent Selection (UM) for Postgraduate Master's Degree Program is carried out by Undip and may work in collaboration with third parties.
- (2) Collaboration with third parties can be in the form of the Independent Selection (UM) for Postgraduate of Institutional Cooperation Patterns (PKSI);
- (3) Further provisions regarding the implementation of new student admissions for the Independent Selection (UM) for Postgraduate Master's Degree Program are regulated by Rector Decree.

Section Two

Independent Selection (UM) for Postgraduate of Institutional Cooperation Pattern (PKSI)

Article 25

- (1) Independent Selection (UM) for Postgraduate of Institutional Cooperation Pattern (PKSI) is carried out by Undip and may work in collaboration with third parties.
- (2) Collaboration with third parties can be in the form of the Independent Selection (UM) for Postgraduate of Institutional Cooperation Pattern (PKSI).
- (3) Further provisions regarding the implementation of new student admissions for the Independent Selection (UM) for Postgraduate of Institutional Cooperation Pattern (PKSI) are enacted by Rector Decree.

Section Three...

Section Three Independent Selection (UM) for Postgraduate Doctoral Program

Article 26

- (1) Independent Selection (UM) for Postgraduate Doctoral Program is carried out by Undip and may work in collaboration with third parties.
- (2) Collaboration with third parties can be in the form of the Independent Selection (UM) for Postgraduate of Institutional Cooperation Pattern (PKSI).
- (3) Further provisions regarding the implementation of new student admissions through the Independent Selection path at Undip are regulated by Rector Decree.

Section Four Selection for the Education of Master to Doctorate for Outstanding Bachelors (PMDSU)

Article 27

- (1) Independent Selection for PMDSU Postgraduate is carried out by Universitas Diponegoro or Ministry.
- (2) Further provisions regarding the implementation of new student admissions through PMDSU Selection are regulated by Rector Decree.

CHAPTER VII SELECTION OF NEW STUDENT ADMISSION FROM PROFESSION PATH

Selection Pattern

Article 28

- (1) Independent Selection (UM) from Profession path is carried out by Universitas Diponegoro and may work in collaboration with third parties.
- (2) Collaboration with third parties can be in the form of the Independent Selection (UM) for Postgraduate of Institutional Cooperation Pattern (PKSI).
- (3) Further provisions regarding the implementation of new student admissions through the Independent Selection path at Undip are regulated by Rector Decree.

CHAPTER VIII...

CHAPTER VIII

SELECTION OF NEW STUDENT ADMISSIONS FOR SPECIALIST DOCTOR EDUCATION PROGRAM (PPDS)

Selection Pattern

Article 29

- (1) Independent Selection (UM) for Specialist Doctor Education Program (PPDS) is carried out by Universitas Diponegoro University and may work in collaboration with third parties.
- (2) Collaboration with third parties can be in the form of the Independent Selection (UM) for Postgraduate of Institutional Cooperation Pattern (PKSI).
- (3) Further provisions regarding the implementation of new student admissions through the Independent Selection path at Undip are regulated by Rector Decree.

CHAPTER IX

COMMITTEE AND DETERMINATION OF PASSING THE SELECTION Article 30

The Rector forms a team to implement the examination selection through the PSSB, Independent Selection (SM) for D-IV/Applied Bachelor, SNMPTN, SBMPTN, Independent Selection (SM) for Bachelor's Degree Program, Independent Selection (SM) for Postgraduate, PMDSU Selection, Independent Selection (SM) for Profession, Independent Selection (SM) for Specialist Doctor Education Program (PPDS) led by the Vice Rector for Academic and Student Affairs who is responsible to the Rector.

Article 31

The Rector determines and decides new prospective students of Undip who have passed the selection for new student admissions.

Article 32

Determination of prospective students who have passed the first stage selection is carried out through a mechanism and is determined through a Focus Group Discussion (FGD) chaired by the Rector.

Article 33

- (1) Prospective new students of Undip are declared as accepted if:
 - a. They have passed the first stage selection in the form of written/ aptitude tests;
 - b. They have passed a medical test or special requirement test; and
 - c. They have met the administrative and financial requirements.
- (2) Prospective students who have passed the selection as referred to in the paragraph (1) are enacted in Rector Announcement.

CHAPTER X...

CHAPTER X MISCELLANEOUS

Article 34

- (1) All payments that have been made by prospective students cannot be refunded.
- (2) The technical requirements for new student admissions of Undip are further regulated in a separate Decree.

Article 35

- (1) The Rector can provide benefits for prospective students who are biological and/or adopted children of Undip employees.
- (2) Biological children as referred to in paragraph (1) are biological children recorded in the Family Card (KK).
- (3) Adopted children as referred to in paragraph (1) are adopted children determined by the Court.

CHAPTER XI CLOSING

Article 36

This Rector Regulation of Undip shall come into effect from the date of its enactment.
